Turn right on to Hyacinth St NE (0.6 mi)
Turn left onto Salem Parkway/OR-99E BR/Salem Hwy. (1.0 mi)
Turn slight right onto Cherry Avenue NE (0.1 mi)

Coming from north of Salem

Merge onto Salem Parkway/OR-99E BR via Exit 260A (2.5 mi)
Turn slight right onto Cherry Ave NE (0.1 mi)
