**W2s being mailed**

The Client Employed Provider (CEP) W2s are being mailed by Thursday, January 11th.

**Provider does not receive W2**

We will not be printing replacement W2s until Monday, January 29th. If the CEP has not received their W2 by then, they can call (503) 947-5138 for a replacement. Please make sure the address is correct. For HCWs check the Oregon ACCESS (OA) record, correct the address on the OA provider address screen if necessary and this information will automatically update PRV8.

**There is an error on the W2**

If there is a reported error on a provider's W2 contact (503) 947-5346 for corrections.

**1099s being mailed**

1099s for the Community Based Care (CBC) providers that provide services outside their own home will be mailed by Friday, January 19th. Providers who provide services in their own homes do not receive 1099s but can request a statement of earnings.

**Provider does not receive 1099 or wants a statement of earnings**

If you have a provider requesting a 1099 or statement of earnings, they can call (503) 947-5138 after Monday, February 12th. Please make sure the address on the PRV8 screen is correct.
