The Community Based Care (CBC) Team has recently gone through some staffing and reorganization changes. In November Allison McKenzie who oversaw the Residential Care Facility Program transferred to our Adult Protective Services Unit. Deb Concidine joined the CBC Team, filling Allison's position. Deb has an extensive background in case management and most recently has been part of the Field Review Team in Central Office.

Other members of CBC team include Lynn Hanson and Melissa Taber. Some of Lynn's duties include reviewing market studies, administrator reference summaries and conducting final reviews for license renewals. Melissa Taber is a new addition to our team as of January 2. Most recently Melissa worked at Northwest Seniors and Disability Services as the Quality Improvement Coordinator for case management. Melissa will be a point person for information requested by the public, providers, and our local offices. She will also be working with the enhanced care and ECOS programs.

In addition to the staffing changes the CBC team is reorganizing. It has been decided that the facilities be divided among the three Program analysts. Each analyst will be responsible for approximately 146 facilities according to an alphabetized list of operators which would include a mix of RCF's, ALF's and ACU's. The purpose of this reorganization is to work more effectively by being more consistent in rule interpretation and information that is provided to the industry, local offices, consumers and advocates.
