Directions to the OMEF Event Center:

From I-5 Northbound:

Take Exit 293 toward Haines Street. Turn Left onto SW Haines Street. SW Haines Street becomes SW Atlanta Street. Turn Left onto SW 68th Parkway. Turn left into OMEF Event Center parking lot.

From I-5 Southbound:

Take Exit 293 toward Haines Street. Turn right onto SW 68th Parkway (Avenue) and then turn right at the next street (SW Clinton). Turn left into OMEF Event Center parking lot.

From Portland Airport:

Follow the signs to Portland. At this point you will be heading south on HWY 205. Take the West I-84 exit to Portland and get in the far left hand lane. Take Salem/City Center/Beaverton exit to I-5 South. At this point please follow directions from I-5 Southbound.

From Beaverton:

Take OR-217 S towards Tigard/Salem. Take the OR-99 W exit (exit 6) toward Tigard/McMinnville. Turn left onto SW Pacific HWY/OR-99W. Turn right onto SW Dartmouth Street. Turn Left onto SW 68th Parkway (Avenue). Turn right at the next street (SW Clinton). Turn left into OMEF Event Center parking lot.

From Downtown Lake Oswego:

Start out going south on 5th Street toward A Avenue. Turn right onto A Avenue. A Avenue becomes Country Club Road. Turn left onto Lower Boones Ferry Road. Turn right onto Kruse Way. Merge onto I-5 toward Portland. Take Exit 293 towards Haines Street. Turn Left onto SW Haines Street. SW Haines Street becomes SW Atlanta Street. Turn Left onto SW 68th Parkway. Turn left into OMEF Event Center parking lot.

Workshop participant should plan to attend all four training topics. This training is specifically designed for and limited to the APD/AAA case managers, case aides, lead workers, supervisors and managers.
