Message: In order to support the Oregon Health Authority and Cover Oregon in their efforts to comply with the Affordable Care Act, the Cherry Ave. Training Center was repurposed to house over 400 temp staff who were hired to get citizens enrolled in insurance coverage. This resulted in the cancelation or relocation of several APD training sessions in November and December.
