Request for Proposals # 3736 for Home and Community Based Care Capacity Expansion opened on the Oregon Procurement Information Network (ORPIN) on January 24, 2014. This Request for Proposal (RFP) process is to expand placement options for persons transitioning out of nursing facilities in the following counties: Clackamas, Columbia, Multnomah, and Washington.

The proposal is requesting 50 “slots” or beds. The RFP will result in new Specific Needs contractors who will be able to provide community-based supports for individuals with complex behavioral or complex ADL needs. Final locations of these 50 beds will be based on which proposals are awarded.
