**Message:**

This is to inform service coordinators, personal agents, and providers of employment services and non-residential day services of a forthcoming action request that will be issued via transmittal.

**Action Required:**

The Office of Developmental Disabilities Services (ODDS) will be issuing results from the employment and day service provider assessments in January, 2016. Initial assessments were completed as required under policy transmittal 15-006 to:

1. Verify accuracy of ODDS Employment and day service authorization, billing, and service delivery, and
2. Measure initial compliance with new state and federal regulations regarding ODDS and Medicaid-funded Home and Community-Based Services (HCBS).

Providers will also be completing this assessment as part of the certification and endorsement renewal process.

Timeline for Requested Action:

Attached to this transmittal, please find **preliminary** service determination results. As outlined below, we are requesting that CDDPS and Brokerages review these preliminary results and submit feedback on or before **Friday January 8, 2016**.

Providers have previously received information regarding the preliminary determination, and had an opportunity to respond or provide additional information. Providers also have until January 8, 2016, to submit additional information if there is a disagreement regarding a determination.
