**Discussion/interpretation:**

Beginning October 1, 2014, a statewide reimbursement rate of \$21.24 will be implemented for both Activities of Daily Living (ADLS) and Instrumental Activities of Daily Living (IADLS) for In-Home Agencies (IHA) only. See APD-IM-14-033 for additional information.

Room and Board rates and Personal Allowance amounts will increase effective January 1, 2015.

Per the Department's collective bargaining agreement with SEIU, effective January 1, 2015, the Homecare Worker rates have been increased.

Beginning January 9, 2015, Homecare Workers (HCWs) who have completed the Oregon Home Care Commission's Enhanced Homecare Worker class will be eligible to receive an enhanced rate of pay when they provide service to specific types of medical or behavioral treatments as part of the consumers person-centered service plans. Training on this new program enhancement will occur in January 2015. Case Managers do not need to take any action at this time.

The new rates are shown on the attached rate schedule.
